Eviction Prevention in Washington State

1. Eviction Resolution Pilot Program

The COVID-19 pandemic brought with it several measures on a national and statewide level to help tenants and landlords with rental assistance and eviction prevention. One of the few state resources in Washington that has not yet expired is the Eviction Resolution Pilot Program (ERPP). The ERPP's purpose is to ensure that tenants and landlords have adequate opportunities to access state and local rental assistance and reimbursement programs.¹

The ERPP, codified under RCW 59.18.660, took effect statewide on November 1, 2021, and expires on July 1, 2023. The ERPP "must be used to facilitate the resolution of nonpayment of rent cases between a landlord and tenant before the landlord files an unlawful detainer action." The ERPP provides for pre-filing dispute resolution, access to civil legal aid for qualifying low-income tenants, and rental assistance funding with the goal of sustaining housing stability.

The ERPP connects landlords and tenants with a specialist at a local Dispute Resolution Center (DRC) to help them resolve the dispute over rent arrears. DRCs are nonprofit public service organizations established in 1984 by the Washington State Legislature to provide avenues for informal resolution of disputes.⁴ Landlords initiate the process by issuing the tenant an ERPP notice that the landlord would like the tenant to take part in the ERPP.⁵ The DRC, upon receiving a copy of the notice, contacts the tenant and invites the tenant to engage in the dispute resolution

process.⁶ Landlords are required to participate in the process if the tenant voluntarily engages.⁷

The DRC connects tenants and landlords to any available rental assistance, offers to help the landlord and the tenant solve the dispute, and provides referrals to other resources as needed.⁸ The overall goal is to help tenants retain housing and to help landlords receive rents owed.⁹ **Appendix B** provides a list of DRCs by County.¹⁰

In the first year of the program, the ERPP served more than 85,000 tenants and landlords: 38,985 cases were closed and completed; 76% of closed cases reached agreements; and 94% of cases preserved tenancy. The ERPP has been very effective at preventing evictions and saving both court costs and time in court.

2. Rental Assistance Programs

Households that received rental assistance during the COVID-19 pandemic can still apply for rental assistance through local programs. **Appendix A** provides a list of rental assistance programs by county. ¹² In Clark County, for example, the Council for the Homeless (CFH) provides rent assistance to eligible residents. ¹³ To qualify for rent assistance at CFH, residents must be behind on their rent and the adults' combined income must be at or below 80% of the Area Median Income. ¹⁴ The amount of assistance available fluctuates monthly due to funding sources. ¹⁵ CFH screens

renters for assistance eligibility on the 6th and the 20th of each month. 16 On those dates, applicants can be screened by phone, in person, or via online portal, beginning at 12:30 pm. 17

3. Looking Ahead

During the 2023 Washington Legislative session, Resolution Washington — the organization that oversees the ERPP — seeks continued funding of \$7.5 million to maintain the ERPP. 18 The organization also has recommendations for improving the program, including:

- educate tenants and landlords on policies and programs,
- improve consistency in program implementation throughout the state,
- modify the program to focus on cases most needing services,
- continue engagement for Black, Indigenous, People of Color (BIPOC) and limited English proficiency residents. 19

As of mid-March 2023, there were several proposed housing-related bills on track for approval.²⁰ Among these is Senate Bill 5197, which addresses Landlord-Tenant relations by providing technical changes to eviction notice forms and modifies certain eviction processes. 21 These measures, like the ERPP, could provide beneficial services to both landlords and tenants in Washington State.
